## 2008 Golf Outing Application and Agreement

**The outing chairperson is required to initialize the following conditions, sign, and return with deposit and request form:**

Thank you for choosing Kingswood Golf Club. We are pleased to have the opportunity to host your special golfing event. Please read the following agreement, as golf events at Kingswood are accepted subject to the following conditions.

**Payment in full for all golf outings at Kingswood must be made prior to the groups start. Payment will be based on the agreed estimate between Kingswood Golf Club and the outing chairperson no less than 7 days prior to the outing. Any reasonable adjustments will be made on the next business day following the outing. Pricing adjustments will not be made on food and beverage options. \_\_\_\_\_**

The final guaranteed number of players and meals must be provided to Kingswood at least 7 days in advance of an outing. \_\_\_\_\_

All outings are subject to the approval of Kingswood Golf Club. \_\_\_\_\_

A reservation fee of 15% of the outing total must be paid to secure your outing date and time. This fee will be applied to your final payment. \_\_\_\_\_

Outing dates and times are booked on a first come, first serve basis. The first group to return their signed outing agreement/application, and deposit will receive priority. \_\_\_\_\_

Shotgun start outings are at the discretion of Kingswood Golf Club and require a minimum of 100 golfers to close the course. Modified shotguns are available for outings of less than 100 golfers, who will share the course with the playing public. \_\_\_\_\_

All outings of 12 or more golfers must include an organized lunch and or dinner provided by Kingswood Golf Club. \_\_\_\_\_

All outings must take golf carts. There will be no exceptions. \_\_\_\_\_

Bringing of alcoholic beverages to Kingswood Golf Club is strictly prohibited. It is a violation of New York State Law and Kingswood Golf Club policy to bring any alcoholic beverage onto Kingswood property. **Patrons may not bring alcoholic beverages to the golf course. Patrons who bring alcohol to Kingswood will forfeit their outing fee and be directed to leave the property.** Beverages may be purchased from the snack bar, grille, or beverage cart. Patrons who exhibit signs of intoxication will forfeit their outing fee and be directed to leave Kingswood property. \_\_\_\_\_

Outings may not bring their own food or non alcoholic beverages to the course. Food and non alcoholic beverages are available at the snack bar, grill, and beverage cart. \_\_\_\_\_

Scoring, cart signs, and proximity signs for your outing will be provided by Kingswood if requested. \_\_\_\_\_

Slow play policy is in effect. Groups must keep pace, or they will be asked to advance to their proper position on the course. Four and ½ hours is an acceptable pace of play. \_\_\_\_\_

Any outing cancelled less than 14 days prior to the scheduled outing date will forfeit their reservation fee/deposit. \_\_\_\_\_

Kingswood Golf Club is a soft spike facility. Soft spikes are available in the pro shop. \_\_\_\_\_

Tax exempt groups are asked to submit form ST-119.1 with their application/agreement form, or will be charged the appropriate tax. \_\_\_\_\_

Kingswood reserves the right to remove any participant who fails to adhere to these guidelines. Participants so removed will forfeit any paid fees. \_\_\_\_\_

Formats and starting times are at the sole discretion of Kingswood Golf Club. We reserve the right to change times and starts as deemed necessary. \_\_\_\_\_

All foursome assignments must be presented to the pro shop five days prior to the event. \_\_\_\_\_

Outing Cancellations due to weather are at the discretion of Kingswood Golf Club. \_\_\_\_\_

**Acknowledgement**

The undersigned acknowledges that he/she has read the outing application/agreement and assumes the obligation of informing all outing participants of the information contained therein. The undersigned further acknowledges that violation of the foregoing guidelines may, at the discretion of Kingswood Golf Club staff, result in the forfeiture of a patron's outing fee and a directive that the patron promptly remove themselves from the property. Patrons are required to abide by all of the above conditions and regulations.

**Authorized Signature and Binding Agreement**

The undersigned represents that he/she has been fully authorized by the above referenced organization to enter into this agreement. The undersigned acknowledges that his/her signature on the application/agreement form will, upon acceptance by Kingswood Golf Club, constitute a binding, legal contract under the terms stated above and further (a) accepts the above stated guidelines (b) will distribute copies of the outing application/agreement to all outing participants covered by this agreement (c) will enforce the above guidelines during the group outing.
